1/18 WELCOME:

The Retiring Mayor, Cllr J Pearson, welcomed Members and Guests to the twenty third Annual Meeting of the Bay of Colwyn Town Council and invited the Town Clerk to make the necessary housekeeping announcements.

2/18 ELECTION OF MAYOR:

Nominations were called for the Office of Town Mayor for the new municipal year.
