216/14 Apologies for Absence:

Apologies for absence were received from the Mayor, Cllr Mrs V Smith, the Chairman, Cllr D Porter, and Cllrs: C Perry; C Wood.

217/14 Declarations of Interest:

Members were reminded that they must declare the existence and nature of any personal and/or prejudicial interests. None were declared.

218/14 Minutes:

- a. Resolved to approve and sign as a correct record the minutes of the last meeting, held on 30th September 2014.
- b. Resolved to receive the draft Minutes of a meeting of the Bonfire Sub-Committee, held on 14th October 2014.

219/14 Matters Arising from Previous Minutes:

- a. Min. 154/14(d) Welsh Government Consultation on Allotments and Community Gardens: The Clerk reported that a letter of acknowledgement had been received from the Welsh Government.
- **b.** Min. 155/14(a) Proposed draft Traffic Regulation Order: It was noted that kerbside markings will be added to the Order for Marine Drive, provided there are no objections, and that an additional short stretch of no parking at Grosvenor Road is to be added to the Order.

220/14 Conwy CBC:

a. The Clerk submitted, for consideration, Notice of a proposed Disabled Persons Parking Places for various locations in the Bay of Colwyn area. It was noted that all those in the Bay of Colwyn area related to revocations.
