#### 448/14 Apologies for Absence:

Apologies for absence were received from Cllr C Perry & the Town Clerk, Mrs Tina Earley.

#### 449/14 Declarations of Interest:

Members were reminded that they must declare the existence and nature of any personal and/or prejudicial interests. None were declared.

## 450/14 Minutes:

Resolved to receive, approve and sign as a correct record the minutes of the last meeting, held on 7<sup>th</sup> April 2015.

### 451/14 Matters Arising from Previous Minutes:

#### Min. 431/14(c) – Street Lighting Energy Consumption:

No response had yet been received from Mr Carrie.

#### 452/14 **Conwy CBC**:

- a. The Assistant Clerk submitted notice of a Traffic Regulation Order for road closures from 15<sup>th</sup> to 17<sup>th</sup> May for Prom Xtra.
   Resolved to receive & note the traffic order.
- b. The Assistant Clerk submitted a copy of the Colliers report on commercial opportunities for phase two of the Colwyn Bay Waterfront Project.
  Resolved to receive and note the report.
- c. The Assistant Clerk submitted a brief update on bus shelters from Gethin George, Conwy CBC. It was noted that the contribution made in 2014/15 was to be refunded and that the Bay of Colwyn's contribution rate per shelter is likely to decrease for 2015/16. The Assistant Clerk asked members to consider funding a replacement shelter for Eirias Park gates (eastbound) from the returned monies.

Resolved to request quotes from Conwy CBC for a replacement shelter at Eirias Park Gates.

**d.** Colwyn Bay Promenade Consultative Group: Cllr B Bagnall & Cllr R Foreman gave a brief verbal report on the meeting attended on 15<sup>th</sup> April.

The issue of mobile homes parking on Old Colwyn Promenade had been discussed and Cllr Bagnall requested that the Clerk write to the County Councillors to ask them for help to enforce the Clwyd County Council Act 1985, Section 14 which would restrict the mobile homes/caravans parking at night.

Dog Exclusion zones were also discussed and it was noted that between Porth Eirias and the Pier would be a dog exclusion zone between 1/5 - 31/9, signs would be erected by 1/5. The Cayley Promenade was already a dog exclusion zone but this did not include the family friendly beach area.

Cllr B Bagnall & Cllr R Foreman were thanked for their report.

The Assistant Clerk submitted a letter regarding the promotion of heritage sites for information.

Resolved to receive the letter.

#### 454/14 Noticeboards:
