Yn gyntaf, fe wahoddwyd Dr Singh i siarad, ac fe amlinellodd y materion a godwyd yn nhaflen newyddion diweddaraf ei feddygfa a ddaeth i sylw'r Cyngor Tref ac a amlygodd yr anawsterau a wynebir oherwydd y nifer o feddygon teulu sy'n ymddeol, yr anawsterau o recriwtio meddygon teulu newydd, y cynnydd yn y gymhareb rhwng cleifion / meddygon a'r her i barhau i gyflwyno safon dda o ofal. Cyfeiriodd at y gostyngiad yng nghyllidebau gofal iechyd a'r cynnydd yn y galw am ofal cychwynnol oherwydd y boblogaeth sy'n heneiddio. Eglurodd Dr Singh bod ei feddygfa ef wedi penderfynu fod yn adweithiol trwy esbonio'r anawsterau a'r heriau hyn i gleifion a thrwy gefnogi mentrau'r Bwrdd Iechyd i greu cysylltiadau agosach gyda nyrsio, ffisiotherapi, gwasanaethau cymdeithasol a therapi galwedigaethol a.y.b. er mwyn esmwytho'r pwysau ar feddygon teulu.

Yna gwahoddwyd i'r Aelodau ofyn cwestiynau a bu'r rhain yn ymwneud a'r materion / pryderon canlynol: colli meddygon teulu a'r anawsterau o gael gweld meddyg teulu - ymateb Dr Singh oedd bod cymdeithas wedi newid a bod yna rŵan fwy o fonitro gofal ac anogaeth i gwyno ac mae hyn o help i godi safonau, ond er y nifer o bethau cadarnhaol a ddaw o hyn, bu hefyd dirywiad graddol yn y

gwerth a roddwyd i'r proffesiwn ar un adeg. Dywedodd hefyd bod polisïau yn cael eu pennu gan ganllawiau, a bod y rhain yn cael eu gwneud am un cyflwr ac nid ydynt yn ystyried hanes meddygol cymhleth y cleifion; holwyd a oedd presgripsiynau rhad wedi ychwanegu at y pwysedd ar feddygon teulu - ymateb Dr Singh oedd mai yn ei farn ef, bod pobl yn dod i'w weld gyda hanesion a phroblemau nad ydynt o reidrwydd yn ymwneud a chael presgripsiynau; pa mor agos at dorbwynt yw meddygfeydd meddygon teulu? - ymateb Dr Singh oedd bod y torbwynt yn agos iawn a'i bod yn poeni bod cleifion yn ymwybodol o hyn ac nad ydynt felly yn dod i'r feddygfa, hyd yn oed pan fyddent yn dioddef; gofynnwyd a oedd y cyllid y pen a dderbynnir gan feddygfeydd wedi lleihau - ymateb Dr Singh oedd bod cyllid y Bwrdd Iechyd yn gostwng o flwyddyn i flwyddyn a bod meddygfeydd yn cael eu hymestyn i'r eithaf gyda'r cyllid y pen a dderbynnir ganddynt ar hyn o bryd.

Yna gwahoddwyd Dr Parry, Dr Rashford a Dr Roberts o Feddygfa Cadwgan i annerch y Cyngor gan y Maer. Dechreuodd Dr Roberts trwy ddweud nad oedd yma i amddiffyn ymarferiad cyffredinol, oherwydd roedd llawer o ardaloedd ar draws y DU yn teimlo'r un wasgfa a meddygfeydd yr ardal hon. Fodd bynnag, roedd yn destun pryder bod mwy o feddygon yn ymddeol yn gynnar ac nad oedd y nifer angenrheidiol o feddygon newydd yn dod ymlaen i gymryd eu lle. Ychwanegodd nad oedd yn sicr bod hyn o fewn rheolaeth y Bwrdd Iechyd, oherwydd mae hwy dan bwysedd cyllidebau. Cyfeiriodd, fodd bynnag, at ei bryderon personol ei hun bod gan y Llywodraeth agenda addatganiedig a dywedodd ei fod yn angenrheidiol i'r pryderon hyn cael eu trafod ar y lefel uchaf. Cyfeiriodd at fodel 'Alaska' sy'n cael ei arwain mewn nifer o lefydd ond na phrofwyd yn helaeth yn y DU hyd yn hyn.

Cyfeiriodd Dr Parry at ymdrechion i annog Meddygon Teulu sydd newydd raddio, i ddod i Ogledd Cymru a mynegodd ei bryderon byddai ailgyflwyno tal am bresgripsiwn yn achosi fwy o gostau gweinyddol a biwrocratiaeth gydag ychydig iawn o arbedion ariannol. Derbyniodd bod gan nyrsys a ffisiotherapyddion a.y.b. eu rhan i chwarae, ond datganodd ei bryderon bod cyllid Meddygon Teulu wedi gostwng o 11% o gyllideb GIG i 7-8% ers i gytundebau newydd Meddygon Teulu cael eu cyhoeddi yn 2004. Nid gofald toredig yw'r peth gorau i gleifion a rhaid i'r flaenoriaeth fod ar gadw cleifion allan o ysbytai lle bynnag may hyn yn bosibl. Byddai symud cyllidebau o ofal iechyd eilaidd i ofal iechyd cychwynnol yn helpu gyda hyn.

Dilynwyd hyn gyda chwestiynau, yn cynnwys pryderon nad yw'r Llywodraeth i weld i fod yn gwrando ar bryderon Meddygon Teulu - ymateb Dr Roberts oedd nad oedd Meddygon yn enwog am gwyno ond yn hytrach yn penderfynu gadael y proffesiwn, rhai ohonynt yn eu pedwardegau (rhyw ugain mlynedd cyn eu hamser); a yw'r Llywodraeth am i ni weld mwy o bobl yn talu i fynd yn breifat? Ymateb Dr Roberts mai yn ei farn bersonol ef, dyna oedd yr achos; pa mor bell ymlaen yw'r cynlluniau am ysgol feddygol yng Ngogledd Cymru? Ymateb Dr Parry oedd nad oeddynt yn symud ymlaen o gwbl ac ni fydd yn digwydd ar unrhyw adeg fuan yn y dyfodol. Fodd bynnag, byddai cael mwy o swyddi hyfforddi yn helpu i gadw'r rhai hynny o'r ardal a hoffai aros a gweithio yma, ond fe all gwaith hyfforddwr fod yn galed ar Feddygon Teulu a chaiff llawer o'r gwaith ei wneud yn eu hamser eu hunain; sut ymatebodd y Bwrdd Iechyd i ymdrechion i helpu denu Meddygon Teulu newydd i Ogledd Cymru? - cafwyd ymateb cadarnhaol ar y cyfryngau cymdeithasol, a ddefnyddir i annog pobl i feddwl am y dewis o gael aros yng Ngogledd Cymru. Fodd bynnag, pe bae Bwrdd Iechyd Prifysgol Betsi Cadwaladr (BIPBC) yn comisiynu'r gwaith hwn, byddai'n ymddangos i fod yn ddull o farchnata yn unig. Dywedodd Dr Parry bod angen am gytwysedd rhwng gonestrwydd a rhesymau dros wneud newidiadau a hybu agweddau cadarnhaol o ymarferiad Meddygon Teulu.

Diolchodd y Maer i holl gynrychiolwyr y Meddygon Teulu am fod yn bresennol ac am rannu eu sylwadau a'u gofidion. Yna gadawsant y cyfarfod ynghyd a'r wasg.

90/11 Apologies for Absence:

Apologies for absence were received from Cllrs: W Bagnall, C Hughes, A Khan,
A Mason, C Perry, Mrs V Smith, C Wood

91/11 Announcements:

There were no announcements from the Mayor.

92/11 Declarations of Interest:

Members were reminded that they must declare the existence and nature of any
personal and/or prejudicial interests. None were declared.

93/11 Visitors to the Council:

- a) The Mayor welcomed representatives from Penrhyn Bay and Cadwgan GP
surgeries, who had been invited, along with other surgeries serving Bay of
Colwyn residents, to address the Council regarding any concerns they may
currently have about GP recruitment.

Dr Singh was invited to speak first and he outlined the issues raised in the
surgery's recent newsletter, which had been brought to the attention of the
Town Council and which had highlighted the difficulties being experienced
due to the numbers of retiring GPs, difficulty recruiting new GPs, increased
patient/GP ratios and the challenges in providing a good standard of care. He
made reference to reducing healthcare budgets and increased in demand for
primary care, due to an ageing population. Dr Singh explained that his
surgery had decided to take a proactive approach in explaining these
difficulties and challenges to patients and supporting health board initiatives
to provide closer links with nursing, physiotherapy, social care services and
occupational therapy etc., to relieve pressure on GPs.

Questions were then invited from Members and these covered the following
matters/concerns: the loss of 'family doctors' and difficulty in getting
appointments to see a GP – Dr Singh responded that society has changed and

there is now more monitoring of care and encouragement of complaints to help raise standards, which has lots of positives but has led to a slow degradation of the value that the profession once enjoyed, he also commented that policies are dictated by guidelines, but that these are made for one condition and do not take into account the complex medical history of patients; it was queried whether free prescriptions had added to pressures on GPs – Dr Singh responded that in his view people come to see him with stories and problems and are not necessarily looking for prescriptions; how close are GP surgeries to breaking point? – Dr Singh responded that they are quite close and he is concerned that patients are aware of this and do not come to the surgery, even when suffering; it was queried whether the funding per head that surgeries receive has gone down – Dr Singh responded that the Health Board's funding is being cut year on year and surgeries are very stretched with the funding per head that they currently receive.

The Mayor then invited Drs Parry, Rashford and Roberts from Cadwgan Surgery to address the Council. Dr Roberts opened by saying he was not here to defend General Practice, as there are many areas across the UK feeling the same pinch as surgeries in this area. However, it is a worrying sign that more doctors are retiring early and the required number of new doctors are not coming forward to replace them. He added that he was not sure this was within the Health Board's control, as they are governed by budget pressures. He instead referred to his personal fears of an unspoken Government agenda and stated that concerns need to be taken to the highest level. He referred to the 'Alaska' model, which is being piloted in several areas but is still largely untested across the UK.

Dr Parry then spoke about efforts to encourage newly qualified GPs to come to North Wales and stated his concerns that reinstating prescription charges would just cause extra administration and bureaucracy and result in little real savings. He added that continuity of care is by far the most important thing in general practice. He accepts that nurses and physios etc all have a role to play, but stated concerns that funding for GPs has dropped from 11% of the NHS budget to 7-8% since new GP contracts were issued in 2004. Fragmented care is not best for patients and the priority needs to be keeping patients out of hospital wherever possible. Moving budgets from secondary to primary care would help this.

Questions then followed, including: concerns about why the government didn't seem to be listening to GPs concerns – Dr Roberts responded that Doctors are not known to whinge and are instead resorting to leaving the profession, some in their forties (some twenty years early); does government want to see more people paying to go privately? – Dr Roberts responded that it was his personal view that this was the case; how far advanced were plans for a medical school in North Wales? – Dr Parry responded that they were not advanced at all and it will not happen anytime soon, however, more training posts would help to keep those from the area who want to stay and work here, but being a trainer is tough on the GP who has to do lots of work in his/her own time; how has the Health Board responded to / helped efforts to attract new GPs to North Wales? – there has been a positive response on social media, which is being used to encourage people to think about North Wales as an option, however, it BCUHB were to commission this work, it would seem like just a marketing ploy. Dr Parry stated that their needed to be a balance between honesty and reasons for making changes and promoting the positive aspects of GP practice.

The Mayor thanked all of the GP representatives for their attendance and sharing their views and concerns and they and the press then retired from the meeting.

- b) The Clerk submitted a response from one other local Surgery, stating they were not experiencing problems with recruitment at the present time and it was noted that the other surgeries had been unable to send representatives.
- c) The Clerk submitted e-mail correspondence from the BCUHB offering to attend this or a future meeting.
