**MINUTES OF A MEETING OF THE GENERAL PURPOSE AND PLANNING COMMITTEE OF THE BAY OF COLWYN TOWN COUNCIL, HELD AT 6.30PM ON TUESDAY 30<sup>TH</sup> MAY 2017, IN THE COMMITTEE ROOM, TOWN HALL, RHIW ROAD, COLWYN BAY**

**PRESENT:** Cllr N Bastow, Chairman

**28/17 Election of Chairman and Vice Chairman for 2017/18:**

*Resolved to re-elect Cllr N Bastow as Chairman and to elect Cllr Mrs Glenys Baker as Vice-Chairman of the Committee for 2017/18.*

**29/17 Apologies for Absence:**

Apologies for absence were received from Tina Earley, Town Clerk and Cllr S Williams who was attending a Mayoral engagement.

**30/17 Declarations of Interest:**

Members were reminded that they must declare the existence and nature of any personal and/or prejudicial interests. None were declared.

**31/17 Minutes:**

*Resolved to approve and sign as a correct record the minutes of the last meeting, held on 2<sup>nd</sup> May 2017.*

**32/17 Matters Arising from Previous Minutes:**

**a. Min. 221/16(c) – CCTV:**

The Assistant Clerk explained the background as to the reason why the Town Council was considering CCTV to obtain evidence of traffic hazards at Rhos Promenade.

**It was resolved to recommend to Council that a permanent Camera be purchased for the site.**

**b. Min. 434/16(b) – Picnic Benches:**

(i) The Assistant Clerk submitted a report from a meeting the Clerk had attended on 16<sup>th</sup> May. It was noted that the March invoice had now been waived by CCBC.

(ii) A quotation for the labour costs for completing the repairs/refurbishment of the final four picnic tables was received. The

Assistant Clerk informed the committee that the painting could be completed by either the Town Wardens or Welsh Baccalaureate Students. *Resolved to accept the quotation and to authorise the Clerk to arrange to have the work completed.*

**c. Min 437/16(a) – Planning Application 0/43780.**

It was noted that it is not possible to impose any conditions when a certificate of lawfulness is granted.

**33/17 Conwy CBC:**

The Clerk submitted, for consideration, the following correspondence from CCBC:

**a. Temporary Traffic regulations**

Emergency works at Station Road until 4<sup>th</sup> June.

**b. Play Equipment Contribution:**

Members were asked to inform the Clerk if any play equipment in their wards needed replacing. The proposals from Conwy CBC were noted.

**c. Rights of Way Improvement Plan:**

Details of the forthcoming review were noted by Members.

**d. Dog Control Orders:**

The Assistant Clerk submitted a copy of a complaint forwarded to Conwy CBC and a reply informing that the current dog control orders will be received in 2018.

Members noted the correspondence.

**34/17 Sub-Committees:**

The terms of reference were approved for the following sub-committees:

- (a) Bonfire
- (b) Christmas Lights

As detailed in Schedule 'B' attached, Cllr Malcom Worth was appointed to serve on the Bonfire Sub-Committee and Cllrs Glenys Baker, Gemma Campbell and Colin Matthews were appointed to serve on the Christmas Lights Sub-Committee.

**35/17 Rhos Bandstand:**

Cllr Mrs G Baker updated the Committee on her progress with her plans for acquiring a bandstand in Rhos on Sea. She had been in discussion with ROSTA

and Conwy CBC who in principle supported the proposal. The Assistant Clerk was asked to contact Llandudno Town Council to enquire about the cost of maintaining their band Stand. Once costs have been ascertained, then it was recommended to refer to the Policy & Finance Committee for possible funding from the Town Council.

Cllr B Barton proposed that the Committee support the proposal in principle. This was unanimously agreed.

#### **36/17 Summer Playing Out Provision:**

- (b) Members received a copy of 'Focus on Play' - a briefing for Community and Town Councils.
- (c) Members received a copy of Manifesto for Children's Play in Wales.

The Assistant Clerk informed the Committee that new delegates would be nominated at the next Council meeting on 12<sup>th</sup> June 2017.
