## **1/17 WELCOME:**

The Retiring Mayor, Cllr J Davies, welcomed Members and Guests to the twenty second Annual Meeting of the Bay of Colwyn Town Council and invited the Town Clerk to make the necessary housekeeping announcements.

## 2/17 ELECTION OF MAYOR:

Nominations were called for the Office of Town Mayor for the new municipal year.

Councillor S Williams proposed the retiring Deputy Mayor, Councillor Jeffrey Pearson, as Town Mayor for the year 2017-18. Councillor A Mason seconded the nomination.

There being no further nominations, Councillor Jeffrey Pearson was unanimously elected as Town Mayor for the ensuing municipal year, 2017-18.

Councillor Pearson was invested with the Chain of Office, took the Chair and made and subscribed his Declaration of Acceptance of Office, which was countersigned by the Clerk as Proper Officer of the Council.

The Mayor then gave a brief verbal address, thanking his fellow members for the confidence placed in him and informing the meeting that his wife, Mrs Kath Pearson, had agreed to act as his Mayoress and that the Reverend John Dowber would be acting as the Mayor's Chaplain.

## 3/17 ELECTION OF DEPUTY MAYOR:

The Mayor called for nominations for the Office of Deputy Mayor.

Councillor Paul Richards nominated Councillor Stephen Williams as Deputy Town Mayor for the ensuing Municipal Year. Councillor A Khan seconded the nomination.

There being no further nominations, Councillor Stephen Williams was duly elected as Deputy Mayor for the ensuing Municipal Year, 2017-18.

The Mayor invested the Deputy Mayor with the Deputy's Chain of Office and Councillor Williams made and subscribed his Declaration of Acceptance of Office, which was countersigned by the Clerk, as Proper Officer of the Council.

The Deputy Mayor gave a brief verbal address, thanking his fellow members for the confidence placed in him. He informed the meeting that his daughter, Chelsea, had kindly agreed to act as his Deputy Mayoress.

#### 4/17 **VOTE OF THANKS:**

Councillor Mrs G Baker proposed a vote of thanks to Cllr John Davies, the Immediate Past Mayor, and Mrs Ann Davies, making reference to the numerous engagements they had attended during their year in Office. Councillor C Hughes seconded the vote of thanks. The Mayor then presented Cllr John Davies with the Past Mayor's Jewel and Mrs Ann Davies with a bouquet, as a token of the appreciation of the Council.

The Immediate Past Mayor gave a verbal address, reflecting on some of the highlights of the past year, and paying thanks to all those that had assisted in raising funds for his Mayoral charities. He confirmed that the total amount raised had been in excess of £2,000. Thanks were also expressed to his Deputy Mayor, Cllr Pearson, and his fellow Members and the Town Council staff for their support and assistance during his year of office.
