80/17 Apologies for Absence:

Apologies for absence were received from Town Clerk, Mrs T Earley.

81/17 Declarations of Interest:

Members were reminded that they must declare the existence and nature of any personal and/or prejudicial interests. None were declared.

82/17 Minutes:

Resolved to approve and sign as a correct record the minutes of the last meeting, held on 11th July 2017.

Resolved to receive the minutes of the Christmas Lights Sub Committee held on 10th July 2017.

83/17 Matters Arising from Previous Minutes:

a) Min. 434/16(b) – Picnic Bench Refurbishment:

Resolved to authorise payment of the revised invoice from Conwy CBC for March work.

b) Min 85/17 – Bus Shelters:

Resolved to receive a written report from the Clerk from the meeting with Gethin George held on 18th July 2017. All members were requested to assist by regularly checking the bus shelters in their wards and reporting any damage/issues to the Clerk.

c) Min 75/17(a)- Town Hall Christmas Tree:

Resolved to agree in principle to hire a large 3m artificial Christmas tree with lights from Blachere for the Town Hall Steps for a 5 year period at a cost of £739.20 p.a., subject to the Assistant Clerk confirming that only one tree is required and this being within the budget available.
