Croesawyd Bleddyn Evans o Gyngor Bwrdeistref Sirol Conwy (CBSC) yn ffurfiol i'r cyfarfod gan y Cadeirydd, er mwyn iddo roi diweddariad am y Swyddfeydd newydd. Rhoddodd Bleddyn gyflwyniad byr am y prosiect er gwybodaeth i aelodau newydd y Cyngor, yn cynnwys y weledigaeth, buddiannau, cerrig milltir allweddol, ffeithiau allweddol a'r prif ddelweddau. Cyfeiriodd at y gost / cyllid y datblygiad a'r brydles 40 mlynedd i GBSC.

Aeth ymlaen i esbonio'r llwyddiannau hyd yn hyn oedd yn cynnwys: gwerth cymdeithasol y cynllun a'r defnydd o nifer o gontractwyr lleol; cyflogaeth i dri o bobl ifanc o ganlyniad i raglen 'Get into Construction' Ymddiriedolaeth y Tywysog; cyfarfod a rhagori ar y targedau a osodwyd gan 'National Skills Academy for Construction'; 14 o swyddi newydd wedi eu creu, 40 wythnos o hyfforddiant wedi eu cwblhau, 3 wedi cael eu gosod mewn gwaith a 4 prentisiaeth newydd; ysgolion yn ymwneud a nifer o fentrau; ag archwilio'r gallu i gyfrannu i welliannau i siopau canol y dref.

Yna aeth Bleddyn ymlaen i roi trosolwg o'r hyn oedd am ddigwydd yn 2018, gyda'r nifer o grefftwyr ar y safle yn dod i'r brig yng nghanol yr haf gydag oddeutu 159 o weithwyr. Y targed i gwblhau'r gwaith a throsglwyddo'r safle yw Hydref 2018 ac yna bydd y staff yn mynychu'r safle cam wrth gan o hynny tan Ionawr 2019. Yna bydd asedau dros ben, yn cynnwys y Ganolfan Ddinesig, yn cael eu rhyddhau i gael eu hailddatblygu. Atgoffwyd yr Aelodau ganddo mai gobaith CBSC a Muse oedd denu buddsoddiad i ddatblygu'r Ganolfan Ddinesig i fod yn westy, ond roedd hyn yn 'annhebygol' i ddigwydd. Y tebyg yw mai datblygiad preswyl fydd yn fwyaf ymarferol ond ni wnaed penderfyniad terfynol ar ei ddefnydd hyd yn hyn.

The Mayor thanked all those who had attended and supported the Fish and  
Chip Supper, which had raised £232.90.

The Mayor extended congratulations to Cllr Glenys Baker and Cllr Gemma  
Campbell for the successful stall held at Rhos Christmas Fayre, which had raised  
£150 for the Mayor's Charities. The Mayor also thanked all those who had helped  
on the day.

**247/17 Declarations of Interest:**

Members were reminded that they must declare the existence and nature of  
any personal and/or prejudicial interests. None were declared.

**248/17 Visitors:**

The Chairman informed the members that due to technical issues with the  
film and subtitles, Liz Millman had requested to defer showing the film until  
the New Year.

The Chairman formally welcomed Bleddyn Evans, CCBC, to give an update on the new CCBC Office development. Bleddyn gave a brief introduction to the project, for the benefit of new members of the Council, to include the vision, benefits, key milestones, key facts and principal images. This included an explanation about the cost/funding of the development and the resulting 40 year lease to CCBC.

He went on to explain the success stories to date, which include: the social value plan and use of a number of local contractors; three young people finding employment as a result of the Prince's Trust 'Get into Construction' programme; meeting/exceeding targets set under the National Skills Academy for Construction; 14 new jobs created, 40 training weeks completed, 3 work placements and 4 new apprenticeships; school engagement on a number of initiatives; and exploring the scope to contribute towards town centre shop front improvements.

Bleddyn then gave a brief overview of what is in store for 2018, with the number of trades on site peaking in mid-summer to around 150 people, a target completion and handover date of October 2018 and then a phased occupation by staff from then up to January 2019. Surplus assets will then be released, including the Civic Centre for redevelopment. He reminded Members that they (CCBC and Muse) had been hoping to attract investment to develop the Civic Centre into a hotel, but that this now looked 'highly unlikely', with a residential development looking to be more viable, but that the ultimate use had not been firmed up as yet.

The Chairman thanked Bleddyn for his presentation and questions were invited from members. A question and answer session followed, covering the following topics: the value of the Civic Centre site; the ratio of fixed desks to staff and how it would work at peak occupancy times; the % of affordable housing that the Civic Centre site would provide; confirmation that there will not be a café on site; concerns about car parking for staff/visitors; the significant capital costs that would be incurred if existing buildings were retained; the reasons a hotel development is unlikely; index linking of annual lease payments; number of electric vehicle charging points to be provided; availability of car parks for use by public at weekends and/or for events.

Bleddyn Evans was then thanked for attending by the Chairman and he retired from the meeting.

Cllr Barton reported that he had attended an event at Chirk, organised by One Voice Wales, with around 40 Councils represented. The Chief Executive of OVW will be collate the comments made and compiling a response on behalf of One Voice Wales. Cllr Barton suggested that the Town Council response be deferred until he has received this information.
