**MINUTES OF A MEETING OF THE GENERAL PURPOSE AND PLANNING COMMITTEE OF THE BAY OF COLWYN TOWN COUNCIL, HELD AT 6:30PM ON TUESDAY 28<sup>TH</sup> AUGUST 2018, IN THE COMMITTEE ROOM, TOWN HALL, RHIW ROAD, COLWYN BAY**

**143/18 Welcome and Apologies for Absence**

The Chairman welcomed members to the meeting and apologies for absence were received from Cllrs: D Bradley, C Brockley and Mrs M Jones.

**144/18 Declarations of Interest:**

Members were reminded that they must declare the existence and nature of any personal and/or prejudicial interests. None were declared.

**145/18 Minutes:**

*Resolved to approve and sign, as a correct record, the minutes of the last meeting, held on 31<sup>st</sup> July 2018.*

**146/18 Matters Arising from Previous Minutes:**

**a) Min. 125/18 – Street Naming Proposals:**

A response from the Licensing Officer, confirming that reasons for a name choice will be asked for in future applications, was received and noted.

**b) Min.123/18(b) – Christmas Lights Sub-Committee:**

*Resolved to approve the updated Terms of Reference for the Sub-Committee, as detailed in Schedule 'A' attached.*

**147/18 Conwy CBC:**

The Clerk submitted, for consideration, the following correspondence from CCBC:

**a) Temporary Traffic Regulation(s):**

- (i) Coed Pella Road, Lansdowne Road and Queens Road – 24/9 to 5/10
- (ii) Cefn Road, Old Colwyn – 15/12 to 16/12 (Xmas Fayre)

*Resolved to receive and note the temporary traffic regulations.*

- b) **Bay Life:** The August 2018 Update was received and noted.
- c) **New Council Offices Coed Pella:** Newsletter was received and noted.
- d) **Bus Shelter:** The Clerk gave a brief verbal report informing members of the removal of a damaged shelter on Abergele Road (by Hesketh Road), due to impact by a vehicle in early June. It was noted that Conwy CBC had no information regarding the vehicle involved in the incident, but that information had been shared on social media and the police had closed the road.

*Resolved to request that the Clerk writes to NW Police to ask for details of the vehicle(s) involved in the incident, so that an insurance claim can be made to replace the removed shelter.*

**148/18 Welsh Government / Conwy & Denbighshire PSB:**

- a) The latest WG PSB Bulletin was received and noted.
- b) The Clerk submitted an invitation to send a representative to a WG Climate Change Adaptation Event in Llandudno on 6<sup>th</sup> September.

*Resolved to request that the Clerk forwards the invitation to Cllr S Williams, as the Council's Future Generations Champion, and that Cllr J Pearson be the reserve representative if Cllr Williams is unable to attend.*

- c) The C&D PSB Summer Update was received and noted.

**149/18 Colwyn Bay Bonfire and Firworks Display:**

The Clerk submitted a verbal request, on behalf of the Bonfire Sub-Committee, for a slight increase in budget (of £500) for additional fireworks to celebrate 50 years of the event in Colwyn Bay. It was noted that enquiries are ongoing to ascertain that this is definitely the 50<sup>th</sup> year anniversary and that the order will only be placed once this is confirmed.

*Resolved to recommend that the budget is increased by £500 and to suggest that the Clerk contacts local historians, Eunice from the library and Graham Roberts, to help find any evidence to the claims.*

**150/18 Carnegie UK – Understanding Welsh Places:**

The Clerk submitted, for consideration, an introductory letter about a grant funded project to fund a web-based tool to provide information about individual towns and communities to anyone interested in their future.

*Resolved to request that the Clerk contacts the Project Officer to enquire if they could help with providing some baseline information to inform a proposed Place Plan for the Bay of Colwyn area.*

### **151/18 Planning Aid Wales:**

- a) The Clerk submitted, for information, the Planning4Communities August 2018 newsletter and Place Plans guidance.

It was noted that the Town Council now needed to take the lead in bringing together a Place Plan Steering Group to lead on the possible production of a Place Plan for the Bay of Colwyn area.

*Resolved to recommend that six councillors (one per ward) be appointed to help form a new Place Plan Steering Group, on the basis of one lead representative and one reserve representative for each of the three distinct communities that the Town Council represents. This would help to ensure that each area is represented at any meeting, but that there isn't over-representation from the Council, on what should be a community-led project.*

- b) It was noted that four members/staff had expressed an interest in attending the Planning training event, to be held on 11<sup>th</sup> September and that several other members had already undertaken the training in the past.

Cllr B Barton asked to be considered as a reserve representative,. any of them were unable to attend at short notice, however, some concern was expressed about the additional cost of travel expenses to Llanrwst.at

### **152/18 Welsh Water – Notice of Works in Rhos on Sea:**

Cllr C Matthews gave a brief verbal report from the drop-in event about proposed upgrade works in Rhos on Sea, which had been, held on 1<sup>st</sup> August 2018. It was noted that residents had received invitations to another event, to be held on 30<sup>th</sup> August and that a couple of Rhos on Sea councillors hoped to attend.

*Resolved to defer this matter to the next meeting, to await more detailed information.*
