**MINUTES OF A MEETING OF THE GENERAL PURPOSE AND PLANNING COMMITTEE OF THE BAY OF COLWYN TOWN COUNCIL, HELD AT 6:30PM ON TUESDAY 15<sup>TH</sup> JANUARY 2019, IN THE COMMITTEE ROOM, TOWN HALL, RHIW ROAD, COLWYN BAY**

**226/18 Welcome and Apologies for Absence:**

The Chairman welcomed members to the meeting and apologies for absence were received from Cllrs: Cllr D Bradley, C Brockley and G Campbell.

**227/18 Declarations of Interest:**

Members were reminded that they must declare the existence and nature of any personal and/or prejudicial interests.

Cllr G Baker declared a personal and prejudicial interest in agenda item 9(a) Planning Application 0/45796.

**228/18 Visitor:**

- a) The Chair welcomed Lianne Martin, Principal Environmental Health Officer, Conwy CBC to the meeting to respond to questions from members regarding proposals for Community Dog Parks.

Lianne explained to members that the proposals had initially been intended for rural wards only, but it had been decided not to be restrictive and to consider them for any ward where a need is identified. They are intended to help in areas which are subject to complaints about dog fouling, animal attacks or anti-social dog behaviour. Once an area has been designated, signage is erected to clearly show the area where dogs can be exercised off-lead.

The success of the project relies on community support/involvement from the outset and the benefits can be far reaching, providing this happens. For example, it may encourage dog walkers to meet together regularly, which can help to tackle loneliness and isolation. It can also help those who don't have/like dogs to identify places they can go where dogs are excluded, or where they have to be on leads and to avoid places where dogs are likely to be off-lead.

A brief question and answer session followed, with questions/concerns

about:

who would monitor any irresponsible dog owners using these areas (this is a shared responsibility, with other dog owners expected to report any inappropriate behaviour); sponsors will be asked to support welfare stations in each area, which would hopefully have water, poop bags and dog toys available for use; whether there were any particular areas in mind in the Bay of Colwyn and if CCBC could provide a list of the open spaces it owns; local dog-friendly cafes; whether there are any costs involved? (the Town Council would be asked to fund approx. 20% of any costs, which is expected to be around £2-£300 per area.

***Resolved to request that Lianne forwards a list of the areas of open space owned by CCBC across the Bay of Colwyn area and identifies any problem areas, where Community Dog parks may be useful.***

Lianne was thanked for attending and then retired from the meeting.

- b) The Clerk informed the Committee that the presentation by James Harland on the HMO SPG and the current LDP Consultation would have to be deferred as James Harland had sent apologies earlier today.

***Resolved to ask that the Clerk tries to rearrange the visit for the next meeting.***

#### **229/18 Minutes:**

***Resolved to approve and sign, as a correct record, the minutes of the last meeting, held on 18<sup>th</sup> December 2018, subject to one minor amendment: the addition of the names of those voting in favour of approving the Minutes (Min. 290/18.***

#### **230/18 Matters Arising from Previous Minutes:**

##### **a) Min.291/18 (e) – Street Furniture:**

- i) Tan Lan (St David's Road) Noticeboard: It was agreed to defer this item to a future meeting, as the Clerk had not yet received any quotations for the replacement of the noticeboard.
- ii) It was confirmed that the following noticeboards had been inspected by members:  
Gorse Road (CM), Cefn Road (MeJ), Colwyn Avenue (GB), Tan Lan Community Centre (MeJ) and Sea View Road (SW). It was noted that the noticeboards at both Cefn Road and Sea View Road needed staples removing.
- iii) Abergele/Hesketh Road Bus Shelter: The Clerk reported that the driver/insurer had been identified and it was noted that a quote had been requested for a new bus shelter.

e) **Min 294/18 – Dog Fouling:**

Cllr G Baker gave a brief verbal update and showed members the poop bag dispensers which had been cable-tied to lamp posts in various locations around Rhos on Sea. It was noted that local businesses/volunteers had agreed to monitor and refill these, as required. Members were asked to consider if there were locations in other wards that might benefit from such a project.

*Resolved to request that members send details of any suggested locations to the Clerk (subject to finding a local business/volunteer to monitor and refill, as required), for forwarding on to Lianne Martin.*

It was noted that Members had some questions/concerns about some of the information in the LDP consultation papers.
