**26/19 Welcome and Apologies for Absence:**

The Chairman welcomed members to the meeting. Apologies for absence were received from Cllrs: D Bradley, G Campbell, and S Williams.

**27/19 Declarations of Interest:**

Members were reminded that they must declare the existence and nature of any personal and/or prejudicial interests. None were declared.

**28/19 Minutes:**

**29/19 Matters Arising from Previous Minutes:**

**(a)Min. 30/19(a)– Hesketh Road Bus Shelter:**

The Clerk updated the members and informed that that she had been advised that the case had been reallocated to a senior case handler who had requested clarification of some details. The Clerk will keep the Committee updated on any progress.
