**427/18 Ymwelwyr a'r Pwyllgor:**

Croesawyd Rachael Gill, CBSC ag Alun Pritchard, Motorsport DU i'r cyfarfod gan y Cadeirydd er mwyn iddynt annerch y Pwyllgor am ddigwyddiad fydd yn dod i'r ardal yn ddiweddarach eleni.

Diolchodd Rachael i'r Cyngor Tref am eu cefnogaeth barhaol a rhoddodd amlinelliad o'i swyddogaeth wrth hybu CBSC fel man i gynnal digwyddiadau rhyngwladol. Bu'n gweithio gyda Rali Cymru GB am nifer o flynyddoedd a chyflwynodd Alun i'r Pwyllgor, fel cynrychiolydd Motorsport UK. Eglurodd Alun ei fod yn ceisio cefnogaeth y Cyngor Tref i ymestyn peth o'r addoliant a'r gweithgareddau i ganol tref Bae Colwyn a Llandrillo yn Rhos pan fydd Rali Cymru GB yn dod i'r Sir unwaith eto ym mis Hydref 2019.

Dangosodd Alun fideo i'r Aelodau, o Rali Cymru GB a gynhaliwyd yn Llandudno yn 2018. Cyhoeddwyd bydd y Parc Gwasanaethau yn cael ei leoli yn Llandudno - yn y gorffennol, hyd at 2013, cafodd ei leoli yng Nghaerdydd ac yna fe'i symudwyd i Lannau Dyfrdwy; o ran bri, roedd y 'rhan strydoedd' yn ail yn unig i Ff1; bu Cymru yn gyson yn rhan o'r digwyddiad ers 1970. Yn 2017 cafwyd 73 miliwn o wylwyr teledu a chyrhaeddwyd 83 miliwn ar y cyfryngau cymdeithasol ac fe gwblhawyd 70,000 o oriau gwirfoddoli.

Y cynllun ar gyfer 2019 yw cael Pencadlys y Digwyddiad yn Llandudno (ar sail 4 diwrnod), gydag 'Ymadawiad Mawreddog' yn y gogledd orllewin ar nos Iau a Rhan Arbennig yn yr ardal ar nos Sadwrn (cyfanswm o 20-25 o rannau). Bydd mwy o fanylion yn cael ei ryddhau yn y ddau fis nesaf.

Yna gofynnodd yr Aelodau nifer o gwestiynau i Rachael ag Alun am y digwyddiad arfaethedig (e.e. y lleoliad, mesurau diogelwch, rheoli tyrfaoedd, cau ffyrdd / effaith ehangach, tocynnau, cysylltu busnesau, hysbysu busnesau a thrigolion, bras amseru, y posibilrwydd o gael ffilm fideo, y posibilrwydd o gael cysylltiad byw i ganol y dref ayb) a chafwyd atebion llawn.

Yna fe gadarnhawyd gan Rachael ag Alun mai'r swm a ddisgwylid i gefnogi gweithgareddau canol y dref ar hyn o bryd oedd £15,000. Dywedodd Rachael ei bod yn annhebygol y cynhelir cyngerdd ar ail ddiwrnod Mynediad Pawb i Eirias eleni, ac felly allai hyn helpu tuag at y swm angenrheidiol. Disgwylir i lwybr y daith cael ei gyhoeddi yng nghanol mis Mai gyda Chysylltiadau Cyhoeddus ar wahân cyn Prom Xtra Bae Colwyn fel y gellir hybu'r digwyddiad ar yr adeg honno.

Mewn perthynas â'r pryderon am yr effaith ar doriadau yn y gyllideb ar lefel Cyngor Sir, dywedodd Rachael, os na fyddai'r Cyngor Sir yn cefnogi digwyddiadau o bwys, yna o fewn ychydig flynyddoedd, fe gollir y momentwm a grëwyd oherwydd mae'n cymryd nifer o flynyddoedd i ddenu digwyddiadau yn ôl i'r ardal yn y lle cyntaf. **424/18 Welcome and Apologies for Absence:**

The Chairman welcomed Members to the meeting. Apologies were received from Cllrs: A Khan, A Mason and T Pearson.

**425/18 Declarations of Interest:**

Members are reminded that they must declare the existence and nature of any personal and/or prejudicial interests. The following interests were declared:

**426/18 Minutes:**

*Resolved to approve and sign, as a correct record, the Minutes of the last meeting held on the 13<sup>th</sup> February 2019.*

**427/18 Visitor to the Committee:**

The Chair welcomed Rachael Gill, CCBC, and Alun Pritchard, Motorsport UK, to address the Committee regarding an event coming to the area later this year.

Rachael thanked the Town Council for their continued support and outlined her role to promote CCBC as a destination for world class events. She had worked with Wales Rally GB for a number of years and introduced Alun as a representative of Motorsport UK. He explained that they were looking for support from the Town Council to extend some entertainment and activities into the town centres of Colwyn Bay and Rhos on Sea, when the Wales Rally GB comes to the County again in October 2019.

Alun showed members a video from the Wales Rally GB event held in Llandudno in 2018. It had been announced that the Service Park would now be located in Llandudno – it had previously been based in Cardiff until 2013 and then moved to Deeside; the ‘street stage’ was second only to F1 in terms of prestige; Wales had consistently been involved since 1973. In 2017, there had been 73 million TV viewers, a reach of 83 million on social media and 70,000 volunteering hours completed.

In 2019, the plan was to have the Event HQ in Llandudno (based for 4 days), with a ‘Grand Depart’ in the North West on the Thursday evening and a Special Stage in the area on Saturday evening (20-25 stages altogether). Further details would be released in the next couple of months.

Members then asked Rachael and Alun various questions regarding the proposed event (e.g. location, protection measures, crowd control, road closures/wider impact, ticketing, business involvement, business and resident notifications, approximate timings, potential for video game footage, possibility of a life stream to the town centre etc) and full responses were provided.

Rachael and Alun then confirmed the amount they were provisionally looking for to support the town centre activities was £15,000. Rachael commented that it was unlikely there would be a second day for the Access All Eirias concert this year, so that may assist with budget provision. The route launch is expected to be in mid-May, with separate PR prior to Colwyn Bay Prom Xtra so that the event could be promoted then.

With regards to concerns about the impact of budget cuts at County Council level, Rachael said that if the County Council did cut its support for major events, within just a few years these would be missed and the momentum would have been lost, as it takes many years to get the events to come to the area in the first instance. Members agreed that cutting funding for events is a false economy.

Rachael and Alun were thanked for their presentation and they retired from the meeting.

- Cllr D Howcroft also left the meeting at this juncture.

#### **428/18 Matters Arising from the Minutes**

##### **(a) Min. 352/18(a) – Theatre accounts for 2017/18:**

The Clerk submitted, for information, a response from Theatr Colwyn regarding line 5255 ‘Tourism and Leisure’ (£80,184) in their budget report, which relates to Venue Cymru technical, box office and administrative staff, who also cover Theatr Colwyn.

##### **(b) Min. 352/18(b) – Youth Engagement:**

The Clerk gave a brief verbal report following meetings held with potential funders and with Emma Pugh (CVSC), Catrin Jarvis (CCBC Youth Council) and Rachel Simmonds (Conwy Youth Service). It was noted that Rachel will be giving a presentation on changes to Conwy's Youth Service provision at the next Council meeting (April) and the Clerk will update and submit her report to that meeting, to include recommendations regarding working more closely in partnership with other bodies who involve young people locally.

The Clerk also informed the Committee she would be attending the Wales Audit Office Workshop Event on Youth Engagement on Thursday 29<sup>th</sup> March.

**(c) Min. 354/18 – Dog Exclusion Zones:**

The Clerk submitted, for information, a response from CCBC which confirmed that the current seasonal exclusion from 1 May to 30 September is still in place. Members discussed how the situation was frustrating and that dog owners are not taking responsibility for picking up after their dogs and that complaints about the issue are rising. It was also noted that CCBC have not yet appointed a replacement to Kingdom, as some County Councillors are reluctant to support greater enforcement action.

The Clerk gave a brief verbal report regarding Members' Allowances and advised that the existing payroll software could still be used for the 4 staff members and the 3 councillors who have claimed their basic allowance for 2018/19.

***Resolved to recommend approving a payment of £15,000 (£5,000 from the Events budget, £10,000 from Access All Eirias budget 2019/20) towards Colwyn Bay / Rhos on Sea town centre activities, in connection with the Wales Rally GB event.***

***Further Resolved to request that the Clerk contacts Rachael Gill to explain concern about the Carbon footprint and the message we are sending our future generations, and ask whether some appropriate ‘green’ activities could be included in wider town centre activities, to help mitigate against this***
