335/19 Welcome and Apologies for Absence:

The Chairman welcomed members to the meeting and apologies for absence were received from D Bradley, C Matthews and M Tasker.

336/19 Declarations of Interest:

Members were reminded that they must declare the existence and nature of any personal and/or prejudicial interests. None were declared.

337/19 Minutes:

Resolved to approve and sign, as a correct record, the minutes of the last meeting, held on 17th December 2019.

338/19 Matters Arising from the Minutes:

a) Min 267/19 - Litter Pick Hub:

The Clerk gave a verbal update informing members that she and the Assistant Clerk had attended a meeting with Phil Vipond, Conwy CBC and Gwyl Roche, Keep Wales Tidy (KWT) to discuss the logistics of the scheme. The plan is to have a hub in 5 Conwy County local areas and our hub will include Llysfaen and Mochdre. KWT will order 20 pieces of kit to be delivered to the Town Hall. Groups will be able to use the hub to store existing equipment, so it can also be shared. Town Hall Staff will issue the equipment and all groups will have to complete an agreement form which KWT have produced. Enquiries via Conwy CBC and KWT will be signposted to us. Once the equipment has been returned, then data has to be submitted to Epi- Collect confirming the location of the litter pick and the number of bags collected. Training will be given to staff to enable them to submit data to Epi-Collect. Members commented it was more work for Town Hall Staff than had been envisaged and this would need monitoring. It was noted that the scheme should be up and running within the next month.

b) Min 316/19(c) – Remembrance Sunday Working Group – VE/VJ Day:
