**MINUTES OF A MEETING OF THE GENERAL PURPOSE AND PLANNING COMMITTEE OF THE BAY OF COLWYN TOWN COUNCIL, HELD AT 6:30PM ON TUESDAY 26<sup>TH</sup> NOVEMBER 2019, IN THE COMMITTEE ROOM, TOWN HALL, RHIW ROAD, COLWYN BAY**

**IN ATTENDANCE:** Several Members of the Public

**193/19 Welcome and Apologies for Absence:**

The Chairman welcomed members to the meeting and apologies for absence were received from Cllr D Bradley.

**194/19 Declarations of Interest:**

Members were reminded that they must declare the existence and nature of any personal and/or prejudicial interests. Cllr C Matthews declared an interest with regard to planning application 0/46821, as a board member of Cartrefi Conwy.

**195/19 Minutes:**

*Resolved to approve and sign, as a correct record, the minutes of the last meeting, held on 29<sup>th</sup> October 2019.*

**196/19 Matters Arising from the Minutes:**

**a) Min 238/19 – Litter Picking Equipment:**

The Chair welcomed Mr Gwyl Roche, Keep Wales Tidy and Cllr Chris Hughes and Mr Bill Mcmillan from the Colwyn Bay Conservation and Environment Federation to the meeting.

Mr Roche informed the Committee that Keep Wales Tidy had been working with Phil Vipond, Conwy CBC to set up an even spread of hubs across the county to store litter picking equipment for community groups to have access to. There is currently one in Betws-y-Coed and one in Kinnel Bay and they are looking for a potential location in the Colwyn Bay/Rhos on Sea area. Gwyl explained that there would be an element of administration involved as the equipment would need to be signed in/out. Gwyl said it would also provide a useful way for groups to co-ordinate with each other so repetition could be avoided.

The Town Clerk advised members that there is a small room available in the annexe at the rear of the police station, which could be easily accessed by car to collect the equipment. Depending on the work involved, Town Hall staff could be responsible for the administration. This would be a convenient location for all local groups and local events could be shared via the Town Council website, social media pages and Colwyn in Bloom's Facebook page. A copy of the guidance/checklist was requested from Keep Wales Tidy. Gwyl confirmed that 20 pickers would be available initially but more can be ordered. Cllr Glenys Baker (representing Rhos pickers) and Colwyn Bay Conservation and Environment Federation supported the Town Hall being a suitable location.

The Chair thanked the representatives for attending the meeting and for their input.

***Resolved to recommend that the Town Council makes the storage room available as a 'hub' and to delegate to Clerk/Chair to progress, once the guidance/terms and conditions have been received/considered.***

The representatives then retired from the meeting.

**b) Min 233/19 – Queen's Gardens:**

The Clerk submitted responses from Lianne Martin and Matthew Frankcom, Conwy CBC.

***Resolved to write to Colwyn County Councillors and the members on the Scrutiny Committee to seek their support in including the Queen's Garden request into the draft report, which is due to be considered at the February meeting.***

**c) Min 234/19 – Understanding Welsh Places:**

Members noted that the Clerk would be attending a launch event at Conwy CBC, Coed Pella Building in December and would report back to a future meeting. The Clerk was asked to inform the organisers that the website isn't suitable for mobile phones.

**d) Min 236/19 – Remembrance Sunday Working Group:**

The Clerk reported that the key people from Remembrance Sunday had met earlier and had had a very positive meeting and good feedback from both Remembrance Services (Colwyn Bay and Old Colwyn). The consensus was that the new format had been successful and would be the format for future years. Cllr M Worth requested that congratulations be passed onto Louise who had been dealing with traffic control and had worked excellently under pressure.

VE day had been discussed and the working group suggested that the celebrations be combined with the 40's Festival with a possible date change

to 15/08/2020. This would need to be agreed with the 40's Festival organisers. The Minister of St Pauls was arranging a special church service and suggested refreshments could be served in the church grounds but this would require funding. The British Legion representatives suggested organising a small service at the War Memorial and possibly going back to the Legion Club afterwards for the 'Toast of the Nation'.

**e) Min 244/19 – Noticeboards:**

The Clerk requested members reports on the condition of the noticeboards in their wards following the quarterly inspections. Rhos councillors reported that the noticeboard on Colwyn Avenue had rotten legs.

*Resolved that the Assistant Clerk updates the quarterly inspection checklist and contact the maintenance man to request a quotation to repair the noticeboard.*

**197/19 Conwy CBC:**

The Clerk submitted, for information/consideration, the following correspondence from CCBC:

**b) Bus Shelters:**

The Clerk informed the members that she had provisionally arranged to meet with Gethin George, Conwy CBC next week and will hopefully update the members at the next meeting.

**c) Future Management of Nature Reserves:**

The Clerk submitted an email from ERF regarding the future management of nature reserves which would include Pwllcrochan Woods. It was also noted that this action appeared to be in conflict with biodiversity requirements set out in Planning Policy Wales (PPW) 10.

*Resolved to ask the Assistant Clerk was asked to contact our representatives on the Pwllcrochan Woods Committee to brief them to ask what 'non-essential' elements meant at the next meeting and to report back to a future meeting.*

**d) Active Travel Route – Rhos on Sea:**

The Clerk submitted confirmation of funding and outline plans which were noted by members.

**e) Bay Life:**

(i) The Clerk informed the members that a report of the Strategic Officer's Meeting, held on 18<sup>th</sup> November was included in the draft minutes of the last Policy and Finance Committee meeting, which had been sent to all members.

(ii) The Clerk submitted information about WG funding for Green Infrastructure which was noted by members.

**f) Imagine Project:**

(i) The Clerk submitted the minutes of the last meeting held on 29<sup>th</sup> October which were noted by members.

(ii) The Clerk informed the Committee that IMAGINE had contacted all local schools to invite them to participate on St David's Day and artists were working with the schools. It was noted that the St David's Day parade will take place on Friday 28<sup>th</sup> February.

**g) Place Plans:**

The Clerk submitted a letter from Shane Wetton which was noted by members.

**h) Community Dog Parks:**

The Clerk submitted a letter confirming that these will not be progressed, which was noted by members.

**i) Empty Homes Strategy:**

The Clerk submitted the consultation document and informed the Committee that an extension had been granted to 27/11/2019.

Members questioned why loans were only granted a property had been empty for 2 years and queried if this encourages the property to be left empty. Could loans be made available sooner? The table on page 11 (9.5) needed clarifying, to explain the statistics and how they have been calculated.

*Resolved that the Clerk respond with the comments/queries detailed above.*

**199/19 N&MWALC:**

Cllr B Barton gave a brief verbal report on the meeting he had attended on 25/10/19.

It was noted that, the Administration needed to be sorted out, following the resignation of Welshpool Town Council from membership. Cllr B Barton said that the presentation on homeless issues by Denbighshire County Council had been very informative and that Denbighshire CC were working closely with the Police and Conwy CBC. The Chair thanked Cllr Barton for his report.

*Resolved to recommend that the Clerk contact Conwy CBC to request if the Officer responsible for homelessness in the Bay of Colwyn area could attend a future Council meeting to give a presentation on the action being taken by Conwy CBC to tackle homelessness.*

**200/19 Llandrillo Ancient Charities:**
