28/21 Welcome and Apologies for Absence

The Chair welcomed all councillors and members of the public to the meeting. Apologies for absence were received from the Mayor, Cllr Mrs M Jones.

29/21 Election of Chair and Vice-Chairperson:

The Chairman, having served his two-year term, asked for nominations for the office of Chairman for the new municipal year.

Cllr C Matthews (Vice-Chairman) was nominated and duly elected as Chairman of the Committee for 2021-22.

Cllr Matthews took the Chair and requested nominations for the office of Vice-Chairman for the new municipal year.

Cllrs G Campbell and J Pearson were nominated for the position of Vice-Chairperson.
