52/21 Welcome and Apologies for Absence

The Chair welcomed all councillors and visitors to the meeting. Apologies for absence were received from Cllr G Baker. Cllr C Matthews J Pearson,

53/21 <u>Declarations of Interest</u>:

Members were reminded that they must declare the existence and nature of any personal and/or prejudicial interests. None were declared.

54/21 Minutes:

Resolved to approve and sign, as a correct record, the minutes of the last meeting, held on 25th May 2021.

55/21 Conwy CBC:

- **a) Temporary Traffic Regulation**: Members noted the temporary traffic regulation for Old Highway, Colwyn Bay for 15/06/21 (BT Work).
- **b) Temporary Traffic Regulation**: Members noted the temporary traffic regulation for the Bridge on the Old Highway, Colwyn Bay from 23/06 25/06/21 (Bridge Work).
- c) Playing Out Scheme: Members noted clarification of the request for funding together with a timetable of activities and a reminder of the locations.
- d) BT Payphone: The Chair welcomed Cllr B Cossey and Mr D Harding Smith to the Meeting. Cllr Cossey, Chair of CCBC's Pier Project Board, informed members that the reason they had asked to address the meeting was to ask that the Council amends/withdraws its request to BT to retain the payphone on the promenade, adjacent to the Pier (requested for safety reasons, due to its beachside location). Cllr Cossey said construction of the new Pier was nearing completion and there were concerns about the impact of the payphone, due to its poor appearance, so CCBC had asked BT to remove it for aesthetic reasons. BT has declined this request, as the Town Council had submitted objections.

Several Councillors addressed the meeting, explaining the reasons the request had

been made to retain the payphone (public safety, in case of emergency). It was also noted that the number of calls would have been much lower than usual, as the payphone had been located behind heras fencing for much of the past year, during the construction of the new pier.

In order to find a compromise, Cllr Cossey asked if the Town Council could help them to find/obtain an old style red phone box, which would not only suit the location better, but may also be able to house a defibrillator too.

Resolved to write to BT (c/o Haf Jones, CCBC) to inform them that the Town Council will amend its objection to the removal of the current BT phone box, providing the payphone is retained and the phone box is substituted with an old-style red phone box.

The Chair thanked Cllr Cossey and Mr David Harding-Smith for attending the meeting and they left.

e) Paddling Pool: Members noted an email regarding the maintenance of paddling pools in the area, in preparation for the lifting of coronavirus restrictions.

56/21 Bus Shelters/Hedges:

The Clerk submitted an email from a resident regarding bus shelters/hedges in the Pen y Bryn area of Colwyn Bay and suggested members consider contacting Conwy CBC to enquire if a scoring system was ever established for prioritising new shelter requests.

Resolved that the Clerk contact Conwy CBC to ask whether the scoring system to establish priority for new shelters had been developed/adopted, and to report back to the Committee in due course.
