80/22 Welcome and Apologies for Absence:

In the absence of the Chair, the Vice Chair Cllr R Owen chaired the meeting and welcomed all members to the meeting. Apologies for absence were received from Cllrs: Brockley, L Kennedy, T Maclean, B Madden and J Nuttall.

81/22 Declarations of Interest:

Members were reminded that they must declare the existence and nature of any personal and/or prejudicial interests. None were declared.

82/22 Minutes:

Resolved to approve and sign, as a correct record, the minutes of the last meeting, held on 14th June 2022.

83/22 Matters Arising from the Minutes:

a) Min 69/22(a) - Wynn Gardens:

The Clerk submitted an email from ERF containing further information, which had been requested in regard to the Town Council taking on responsibility for maintaining proposed new solar lighting at Wynn Gardens. A number of queries were raised by members, including: how many lights are planned, who is paying for the supply and installation costs, what is the column height and how frequently will they need to be inspected (including basic visual H&S and periodic electrical inspections.)

It was resolved to support the proposal in principle and request further information from B Cossey, in response to the queries raised.

b) Min 69/22(b) – Min y Don Park:

Cllr S Ryder informed the members that she had attended a meeting of the newly reformed Old Colwyn Environment Federation group on Thursday 30/6/22. The subject of bins in Min y Don Park had been discussed and Cllr Ryder asked that this item be deferred pending further information.

84/22 Conwy CBC: Members received and noted the following correspondence:

85/22 Refuse Bins in Eirias Park:

The Clerk submitted an email and photograph from Cllr Nuttall suggesting the possible relocation of bins in Eirias Park. Cllr S Ryder offered to raise this with the Colwyn Bay Environment Federation when they meet next week and report back.

86/22 Barclays Bank:

The Clerk submitted correspondence from David Jones MP, our response and an email from Cllr T Maclean regarding the loss of Barclays Bank and possible relocation. Suggestions of the Library or Coed Pella were made. Members questioned whether the bank could make mobile provision as they do in rural areas.

Resolved to refer this to Council.

87/22 Guide Dog EV Charging Points Position Statement:

The Clerk submitted an email and statement from Cllr R Owen. Cllr Owen said we need to be aware of this for future developments but that it was not a legal requirement at the moment. Members noted the correspondence.

88/22 50, Llysfaen Road, Old Colwyn:

The Clerk submitted an email requesting name suggestions for the recently built development in Old Colwyn. The Clerk asked for any suggestions to be submitted by Friday.

Resolved to delegate authority to the Clerk to reply once suggestions have been received.

89/22 Age Friendly Communities in Partnership Webinar.

Cllr J Higgins gave a brief report from a webinar he had attended on 29/6/22. Cllr Higgins started by saying the webinar had been very interesting and that the

message was that we would all hopefully grow old one day and will want access to a good community life. Barriers need to be removed for ageing well. Communities need to be 'age friendly'. Cardiff is the first city to be a WHO age friendly city and is an aspiration for all communities to participate. Those aged 60+ are the biggest growing population segment; many are heavily involved in their local community: volunteering, caring ad running businesses. The Welsh Government have allocated £1.1Million to Local Authorities to support age friendly communities. Case studies were shared and will be circulated to members. The Chair thanked Cllr Higgins for his informative report.

Resolved to invite Cllr Higgins to the next Community Wellbeing Network Meeting to give a presentation.
