

Competition Terms & Conditions

- For the purposes of these Terms and Conditions, "The Promoter" refers to "The Bay of Colwyn Town Council" whose Instagram handle is @Bayofcolwyntc and Facebook handle is Bay of Colwyn Town Council. The "Prize" refers to two (2) N-Dubz concert tickets for Saturday 22nd July at Stadiwm CSM, Eirias Park, Colwyn Bay.
- By entering the competition, you agree to be bound by these terms and conditions. All entries must be received by 4pm on 22nd June 2023. Five (5) winners residing in the Bay of Colwyn area (Old Colwyn, Colwyn Bay, Rhos on Sea and Upper Colwyn Bay) will be selected randomly and the winners will be notified on or shortly after 23rd June 2023.
- The Promoters competitions with entry via Instagram or Facebook are open only to residents of the Bay of Colwyn. Five (5) winners will be chosen from across either platform.
- No purchase necessary. Winners will not be required to pay to enter the competition.
- Winners under 16 years old must be accompanied at the event by an adult 18+.
- Employees and Members of The Promoter are not eligible to enter.
- Instagram or Facebook are not in any way affiliated or involved in the competition.
- Only one entry per person per competition will be accepted.
- Each entrant shall enter the competition via Instagram or Facebook by following the Bay of Colwyn Town Council Instagram or the Bay of Colwyn Town Council Facebook page, liking the competition post, then commenting to say 'who they would take with them to the N-Dubz concert on Saturday 22nd July 2023'.
- The Prize will be awarded to the five randomly selected entrants who have fulfilled the competition criteria, The Promoter's decision is final.
- The Promoter will not be held liable if the named prize becomes unavailable or cannot be fulfilled.
- The Promoter will not be held liable for any failure of receipt of entries. The Promoter takes no responsibility for any entries which are lost, delayed, illegible, corrupted, damaged, incomplete or otherwise invalid.
- To the extent permitted by applicable law, The Promoter's liability under, or in connection with the competition, or these terms and conditions, shall be limited to the cost price of the Prize in question.
