1. Bydd pob Cais yn cael ei ystyried gan y Pwyllgor Polisi a Chyllid.
2. Rhaid i bob cais am dros £2000, i'w ddyfarnu fel grant yn y flwydd yn ariannol ganlynol (wedi 1^{af} Ebrill), cael ei dderbyn gan y Cyngor erbyn 31^{ain} Rhagfyr. Bydd y ceisiadau hyn yn cael eu hystyried yn lonawr ac **ni chaiff ceisiadau hwyr eu hystyried.**
3. Bydd y Pwyllgor Polisi a Chyllid yn ystyried ceisiadau am £2000 a llai, pob chwarter.
4. Mae'r Cyngor Tref yn gofyn i holl ymgeiswyr am gymorth ariannol fod a chyfansoddiad ysgrifenedig a chyfrif banc ar wahân a chyflwyno datganiad archwiliedig o'u sefyllfa ariannol.
5. Wedi'r Pwyllgor Polisi a Chyllid ystyried y cais ac i'r Cyngor Tref ei gadarnhau, bydd Clerc y Dref yn gadael i bob ymgeisydd wybod, yn ysgrifenedig, a fu'r cais yn llwyddiannus ai peidio.
6. Rhaid i'r arian a roddir i unrhyw fudiad cael ei ddefnyddio, naill ai yn uniongyrchol neu yn anuniongyrchol, er budd trigolion ardal ddaearyddol y Cyngor Tref h.y. Llandrillo yn Rhos, Bae Colwyn a Hen Golwyn.
7. Cyfrifoldeb y Mudiad yw cyflwyno cais i'r Cyngor Tref. **Ni fydd y Cyngor Tref yn dosbarthu ffurflenni cais.**
8. Dylai mudiadau fod yn ymwybodol mai dewis y Cyngor Tref yw penderfynu ar unrhyw ddyfarniad a wneir a maint unrhyw ddyfarniad. **Nid yw grantiau yn rhedeg o un flwyddyn i'r llall.** Rhaid i'r ymgeisydd datgan os yw cais wedi cael ei wneud / a dderbyniwyd grant gan fudiadau eraill yn cynnwys Cyngorau Lleol eraill, a chyflwyno tystiolaeth o weithgareddau a wnaed eisoes i godi arian.
9. Fe ofynnir i unrhyw fudiad / ymgeisydd am grant o £2000 neu fwy mewn un flwyddyn ariannol, cyflwyno adroddiad ysgrifenedig ar sut cafodd yr arian ei ddefnyddio. Rhaid cyflwyno'r adroddiad o fewn 6 mis o ddiwedd y flwyddyn ariannol y dyfarnwyd y grant (h.y. erbyn 30^{ain} Medi). **Os na chyflwynir adroddiad o fewn y cyfnod o 6 mis, gall hyn beryglu pob cais arall yn y dyfodol.**
10. Bydd grantiau o £2,000 a throsodd a ddyfarnwyd i gynorthwyo efo gwariant refeniw yn cael eu talu mewn dwy ran, yn Ebrill a Hydref, ac efallai bydd unrhyw gais llwyddiannus dilynol yn cael ei leihau o 20% pob flwyddyn er mwyn annog ymgeiswyr i gael ffynonellau ariannol cynaliadwy hir dymor eraill.
11. Bydd grantiau o £2,000 a throsodd am bryniant cyfalaf yn cael ei dalu naill ai mewn un neu dwy ran yn ôl dewis y Pwyllgor.
12. Dylid anfon ceisiadau Gyngor Tref Bae Colwyn, Neuadd y Dref, Ffordd Rhiw, Bae Colwyn, LL29 7TE ac fe gydnabyddir pob cais.

**BAY OF COLWYN TOWN COUNCIL'S CRITERIA FOR CONSIDERING GRANT APPLICATIONS FROM
VOLUNTARY AND CHARITABLE BODIES**

13. All Applications shall be considered by the Policy and Finance Committee.
14. The Council must receive all applications of over £2000 by the 31st December for awarding grants in the following financial year (after 1st April). These applications will be considered in January and **late applications will not be considered.**
15. The Policy & Finance Committee will consider applications of £2000 and less, quarterly.
16. The Town Council requires all applicants for financial assistance to have a written constitution and separate bank account and to provide an audited statement of their financial affairs.
17. After consideration by the Policy & Finance Committee and ratification by the Town Council, the Town Clerk will inform all applicants, in writing, whether or not their application has been successful.
18. Funds given to any organisation must be used to benefit the residents of the geographical area represented by the Town Council i.e. Rhos-on-Sea, Colwyn Bay and Old Colwyn, either directly or indirectly.
19. The onus is on the Organisation to submit its application to the Town Council. **The Council will not distribute application forms automatically.**
20. Organisations should be aware that any award made and the amount thereof is at the discretion of the Town Council. **Grants are not on-going year on year.** The applicant shall indicate other funding applied for/granted from other organisations, including other Local Councils, and give evidence of fund raising activities already undertaken.
21. Any organisation / applicant receiving a grant of £2000 or more in any one financial year will be required to provide a written report of how the money has been used. The report must be provided within 6 months of the end of the financial year in which the grant was made (i.e. by 30th September). **If a report is not provided within the 6 month period, all future applications may be placed in jeopardy.**
22. Grants of £2,000 and over awarded to support revenue expenditure will be paid in two instalments, in April and October, and any subsequent successful application may be reduced by 20% each year to encourage applicants to secure alternative long term sustainable funding sources.
23. Grants of £2,000 and over awarded for capital purchases may be paid in either one or two instalments, at the discretion of the Committee.
24. Applications should be submitted to the Bay of Colwyn Town Council, Town Hall, Rhiw Road, Colwyn Bay, LL29 7TE and will be acknowledged.

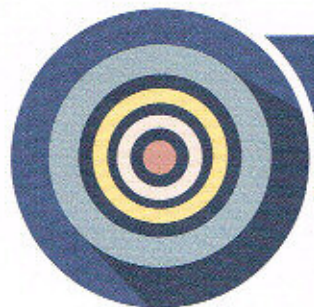


Nodau Llesiant

Mae'r saith o nodau Llesiant yn dangos y math o Gymru rydym eisiau ei gweld. Gyda'i gilydd maent yn darparu gweledigaeth ar y cyd ar gyfer y cyrff cyhoeddus sydd wedi'u rhestru yn y Ddeddf, i weithio tuag ati.

Maent yn gyfres o nodau; mae'r Ddeddf yn datgan yn glir bod rhaid i gyrff cyhoeddus weithio i gyflawni'r holl nodau, nid dim ond un neu ddau.

Cymru lewyrchus	Cymdeithas arloesol, gynhyrchol, carbon isel sy'n cydnabod y terfynau sydd ar yr amgylchedd byd-eang ac sydd, o ganlyniad, yn defnyddio adnoddau mewn modd effeithlon a chymesur (gan gynnwys gweithredu ar newid yn yr hinsawdd); ac sy'n datblygu poblogaeth fedrus ac addysgedig mewn economi sy'n cynhyrchu cyfoeth ac yn cynnig cyfleoedd cyflogaeth, gan ganiatáu i bobl fanteisio ar y cyfoeth a gynhyrchir drwy gael gafael ar waith addas.
Cymru gydnerth	Cenedl sy'n cynnal ac yn gwella amgylchedd naturiol bioamrywiol gydag ecosystemau iach gweithredol sy'n cynnal cydnerthedd cymdeithasol, economaidd ac ecolegol ynghyd â'r gallu i addasu i newid (er enghraifft newid yn yr hinsawdd).
Cymru iachach	Cymdeithas lle mae Llesiant corfforol a meddyliol pobl cystal â phosibl a lle deallir dewisiadau ac ymddygiadau sydd o fudd i iechyd yn y dyfodol.
Cymru sy'n fwy cyfartal	Cymdeithas sy'n galluogi pobl i gyflawni eu potensial ni waeth beth fo'u cefndir neu eu hamgylchiadau (gan gynnwys eu cefndir a'u hamgylchiadau cymdeithasol-economaidd).
Cymru o gymunedau cydlynus	Cymunedau atyniadol, hyfyw a diogel sydd â chysylltiadau da.
Cymru â diwylliant bywiog lle mae'r Gymraeg yn ffynnu	Cymdeithas sy'n hyrwyddo ac yn gwarchod diwylliant, treftadaeth a'r Gymraeg ac sy'n annog pobl i gyfranogi yn y celfyddydau, a chwaraeon a gweithgareddau hamdden.
Cymru sy'n gyfrifol ar lefel fyd-eang	Cenedl sydd, wrth iddi wneud unrhyw beth i wella Llesiant economaidd, cymdeithasol, amgylcheddol a diwylliannol Cymru, yn ystyried a allai gwneud peth o'r fath gyfrannu'n gadarnhaol at lesiant byd-eang.



Well-being Goals

The seven well-being goals ('the goals') show the kind of Wales we want to see. Together they provide a shared vision for the public bodies listed in the Act to work towards.

They are a set of goals; the Act makes it clear the listed public bodies must work to achieve all of the goals, not just one or two.

Goal	Description of the goal
A prosperous Wales	An innovative, productive and low carbon society which recognises the limits of the global environment and therefore uses resources efficiently and proportionately (including acting on climate change); and which develops a skilled and well-educated population in an economy which generates wealth and provides employment opportunities, allowing people to take advantage of the wealth generated through securing decent work.
A resilient Wales	A nation which maintains and enhances a biodiverse natural environment with healthy functioning ecosystems that support social, economic and ecological resilience and the capacity to adapt to change (for example climate change).
A healthier Wales	A society in which people's physical and mental well-being is maximised and in which choices and behaviours that benefit future health are understood.
A more equal Wales	A society that enables people to fulfil their potential no matter what their background or circumstances (including their socio economic background and circumstances).
A Wales of cohesive communities	Attractive, viable, safe and well-connected communities.
A Wales of vibrant culture and thriving Welsh language	A society that promotes and protects culture, heritage and the Welsh language, and which encourages people to participate in the arts, and sports and recreation.
A globally responsible Wales	A nation which, when doing anything to improve the economic, social, environmental and cultural well-being of Wales, takes account of whether doing such a thing may make a positive contribution to global well-being.

Pam dylwn i adio gwybodaeth am fy ngwasanaeth i at Dewis Cymru?

Ar hyn o bryd mae Dewis Cymru yn cynnig tua 25 miliwn o ganlyniadau chwilio bob mis, sy'n golygu y bydd gwybodaeth am eich gwasanaeth chi'n weladwy i ddarpar ddefnyddwyr gwasanaeth/cwsmeriaid ar hyd a lled Cymru. Mae rhesymau da eraill i'w ddefnyddio Dewis Cymru yn cynnwys:

Do you provide a service that can help people with their well-being?



Add your information to Dewis Cymru – THE place to find information about a range of well-being services in Wales.

Dewis Cymru aims to help people with their well-being by sharing information about a wide range of local and national organisations and services, allowing them choice and control over which services can best meet their needs. It is also useful for people like GPs, Librarians, Social Workers and lots of local organisations who offer information to the public as part of their work.

Why should I add information about my service to Dewis Cymru?

If you've got a service that helps people with their well-being, adding your details to Dewis Cymru will make it easier for them to find you. Dewis Cymru currently serves up around 25 million search results each month, which means that information about your service will be visible to potential service users/customers across Wales. Other good reasons to use Dewis Cymru include:

- It's free
- It's easy to register and add your details
- It will remind you every six months to check your details, so you'll know they are up to date
- It provides maps and directions to your service (where appropriate) to help people find you
- It's already being used by many advice agencies to direct people to local services that can help them, so having your information on Dewis Cymru will mean that people can be directed to your service.

So, what do I do next?

To add your information, you'll need to register. Go to www.dewis.wales and 'Sign up' to create your account. Once you've done this, 'Sign in' to the site and go to 'Manage resources' and 'Add resources' to add information about your services.

Can I add information about any service?

Yes. We encourage people to add information about specific services that they offer. So, if you run a community group you can add details of what it's about, where and when it meets, and how to get in touch. If you represent an organisation which provides a range of services, please add the services individually so that users of the site can find the services they're looking for.
